Trade Secrets: The Bid Protest Mechanism under Domestic Trade **Agreements**

Manitoba became a signatory to the Canadian Free Trade Agreement (CFTA) in 2014 and the New West Partnership Trade Agreement in 2017. In 2019, government-owned enterprises, municipalities, academic institutions, schools and hospitals also became subject to domestic trade agreement procurement obligations. In 2015, a "bid protest mechanism" was established which provided suppliers with an administrative review process for complaints that a public sector entity did not comply with its trade agreement obligations in conducting a procurement process.

This session will provide a general overview of the bid protest mechanism and arbitral decisions to date, strategies to ensure compliant procurement processes and insights from legal counsel in Saskatchewan (Highways) v. West-Can Seal Coating Inc, 2022 SKQB 43. This session will be of interest to lawyers for both public sector organizations and commercial suppliers of goods and services.

The Supreme Court Considers An Act Respecting First Nations. Inuit and Métis Children, Youth and Families in Attorney General of Québec, et al. v. Attorney General of Canada, et al.

In December 2023, the SCC was asked to decide whether An Act Respecting First Nations, Inuit and Métis Children, Youth and Families ("the Federal Act") was ultra vires the Constitution after the Quebec Court of Appeal found sections 21 and 22(3) unacceptably altered the fundamental architecture of the Constitution. Several Manitoba-based interveners participated in the appeal at the SCC. The Child and Youth Law Section is excited to be able to have counsel involved share their perspectives on the case, the experience of appearing at the SCC, and the experience applying the legislation within Manitoba. The SCC has not yet released its decision in this case, but it is anticipated that it will be released in advance of the session and that the panel can speak to the ultimate outcome.
