Wills & Estates Law Section Report 2015-2016

November 13 and 14, 2015 John Delaney, Chair of the Wills and Estates Section, (Tradition Law LLP) attended the CBA National Wills, Estates and Trusts meeting in Ottawa on behalf of Manitoba's Section. The most salient parts of the agenda included: Nature and status of further submissions by the National Section to the federal government for consideration in the 2016 budget on the changes to graduated rate estate taxation, including ongoing lobbying of the federal government to reverse its intention to tax gains on capital assets of a life estate trust deemed to arise from the death of the life estate beneficiary on the beneficiary's estate tax return rather than the trust tax return; consideration of formal submissions from the National Section to the federal government on pending legislation on medical assistance in dying; consideration of ongoing status of a project between representatives of the National Section and representatives of the Canadian Bankers Association intended to inform and educate both the banking industry and the legal profession of their respective concerns and issues in dealing with the elderly population, powers of attorney and joint accounts and the impact each profession's actions, advice and dealings has on the other; the development of a Children's Law Committee to deal with estate issues for children; status of the 2016 National Section in-person Estate Planning Course scheduled for Toronto in fall/winter of 2016; proposals for future webinar programs; ongoing updating of the National Concordance Tables.
